In the event of dissolution or winding up of the Trust the assets remaining as on date of dissolution shall under no circumstances be distributed among the members of the Trust but the same shall transferred to another charitable trust/ trust/societies whose objects are similar to those of this trust and which enjoys recognition u/s. 80G of the I.T. Act 1961 as amended from time to time.


22. **IRREVOCABILITY**

It is declared that the trust is irrevocable. If the trust fails for any reason, in the opinion of the trustees, proceeds of net assets of the trust, records of the net assets of the trust both movable and immovable shall be handed over at the discretion of the majority of the trustees to any other.





24. MANAGING TRUSTEE/SECRETARY OF THE TRUST

The secretary shall borrow the funds/loans from nationalized, schedule and non scheduled banks, Pvt., financial institutions, commercial banks, co-operative banks and any other bodies for acquisition of movable/immovable properties whenever necessary and pledge/mortgage the properties . And also buying a vehicles.
- ix. He/she shall be the supreme authority of the executive committee and shall exercise a casting vote in the event of their being a tie of members on any decision on any matter concerning trust and his/her vote shall be binding and final. He shall preside over all the meetings of the trust and shall guide managing committee in day to day activities of the trust.
